SUBJECT: Enhanced IATF Certification Body Performance Metrics System

The purpose of this communication is to advise all IATF-recognized certification bodies of an additional/enhanced set of performance indicators.

The IATF has observed that the constant monitoring of the current IATF Database KPIs (20-day metric, 120-day metric, 7 day and 20-day upload metric) resulted in significant improvements in the certifications body's internal processes and consequently in major improvements for the IATF certification scheme as a whole. Meanwhile the vast majority of the IATF-recognized Certification Bodies are meeting the established targets for these IATF Database KPIs.

The IATF has now developed two new indicators to add focus to client audit results in addition to the current IATF-recognized Certification Body processes.

Based on the client audit results that are entered in the IATF Database, the IATF is not only able to derive important information for the IATF certification scheme but it is also able to monitor the audit results for e.g. non-witnessed vs. witnessed audits.

Based on a systematic analysis of the past year's data and results, concerns were expressed by the IATF with regard to the significantly different audit results for non-witnessed vs. IATF-witnessed audits.

The enhanced two new IATF Certification Body Performance Metrics consist of two new ratios that highlight the significant difference between non-witnessed and IATF-witnessed audits.

As per the attached global data (see page 3) for e.g. 2016 calendar year, it is evident that certification bodies issue 2,51-times more nonconformities under witnessed conditions and the percentage of major nonconformities is 5,59-times higher than under non-witnessed

conditions. At the same time the number and percentage of audits resulting in zero nonconformities under witnessed conditions is also close to zero.


This set of additional performance indicators will continuously be measured from 2017 onwards. The data for the past 5 years has already been analyzed and the global result is visible for each year in the chart on page 3.

The current IATF database KPIs (20-day metric, 120-day metric, 7 day and 20-day upload metric) will continue to be monitored and followed-up on as necessary.

All IATF-recognized certification bodies are encouraged to download and analyze the nonconformity data in the same way to compare audit results under witnessed conditions vs. non-witnessed audits. CB's should analyze and investigate the data and it's root causes for significant differences in non-witnessed and witnessed audits and implement actions to narrow the gap between them.
